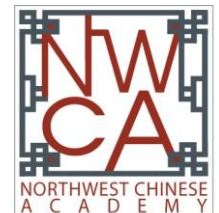
Parents will be invited to join us for a performance on the last day of each session. This performance will highlight everything the children have discovered during the camp session.

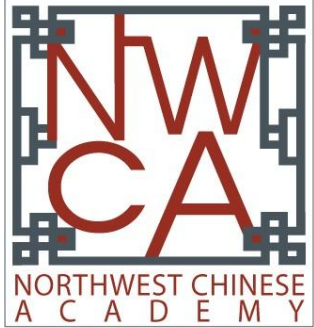

In an emergency, the Northwest Chinese Academy has my permission to call an ambulance to take my child to any available physician or hospital at my expense and to obtain medical treatment for my child. In most emergencies, 911 is called and the child is transported to nearest hospital and seen by Dr. on call. (Parents are always notified as soon as possible.)

My child may be given non-prescription medication as indicated on the container including, sunscreen, children’s pain reliever, antibacterial first aid cream and ointment. Syrup of ipecac may be administered if deemed necessary by the poison control operator. (We will contact parents prior to administering non-prescription pain relievers.) 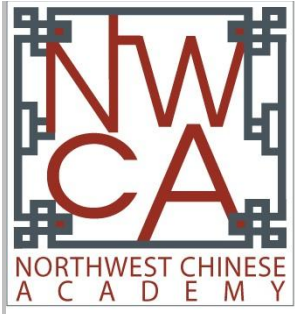

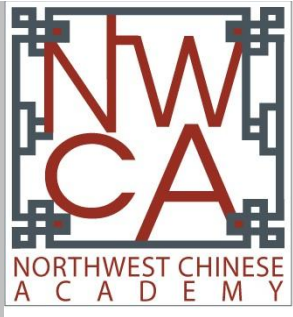
